### **ORDER**

Due to Covid-19 lockdown imposed by the Government of Tamil Nadu this Commission due to the constraint of conducting the enquiry in person, conducts the enquiry through telephone and online. Hence this case was taken in to enquiry on 03.11.2020 through telephone. During the enquiry the petitioner Thiru D. Hemnath, Vellore and the Public Information Officer, Superintendent of Wakfs, Vellore zone, Vellore was present for the telephone enquiry.

2. A perusal of the petition dated 13.04.2019 filed under section 6(1) of the R.T.I. Act, 2005 reveals that the petitioner has sought the information regarding the details of list of all types of land and properties belonging to and/or owns and / or managed by all kinds of management like Mutawalli, Management Committee, Wakf Board, Administrator and Any kind of management types under any kind of Wakf Board or Wakf Board of India (Central Wakf Council) located in Vellore District, Arcot Taluk, Sathur Village 632521. Also the petitioner seeks information of all kinds lands and plots or all kinds of properties located in Vellore District, Arcot Taluk, Sathur Village with Village name and Complete Address and exact location, boundaries specification, Patta Numbers and Survey Numbers and Sub-Division numbers, Property area size in acres in Sq.Feet, Location Code, Land or Property type, property managed from dated by

Wakf Board or any classification under wakfs, property's current status and current management type.

3. The Public Information Officer has denied to provide information vide letter dated 24.04.2019. As the petitioner was not satisfied with the information, the petitioner has preferred a First Appeal dated 30.04.2019 under section 19(1) of the RTI Act, 2005. The Appellate Authority has not provided any information and hence the petitioner has preferred a Second Appeal under section 19(3) of the RTI Act, 2005 before this Commission on 01.07.2019 and the said appeal has been taken up for today's (03.11.2020) enquiry.

4. During the telephone enquiry, the petitioner stated that has not received any from the Public Information Officer and the petitioner insisted this Commission to provide the complete information without any omission.

5. During the enquiry, the Public Information assured to provide the complete information within 15 days to the Petitioner.

6. In the facts and circumstances of this case, this Commission finds that information sought by the petitioner was not fully provided to the petitioner. Hence, the Public Information Officer is hereby ordered:

- The Public Information Officer is hereby ordered to provide the complete information to the petitioner by RPAD within 15 days under Section 7(6) of Right to Information Act from the date of receipt of this order and report compliance to this Commission.
- The Commission further orders that if the Public Information Officer fails to provide requisite information during the said period of 15 days action will be initiated under section 20(1) of the Right to Information Act.
