1. Both the parties were present. The information asked for by the petitioner has been supplied on 02.09.2009 on the basis of which the petitioner has come on appeal to the Commission on 26.09.2009. If only the reply furnished on 02.09.2009 was given to the petitioner within 30 days from the date of receipt of the original R.T.I. petition, the need for conducting the enquiry on 18.08.2009 would not have arisen. It is only on the basis of the enquiry held on 18.08.2009, the above said reply has been sent to the petitioner. Not satisfied with the information so supplied, the petitioner has come on appeal once again to the Commission on 26.09.2009, which is under enquiry now.

2. The petitioner has asked for information about the enquiry report received from the Inspector and the Deputy Superintendent of Police on the basis of the

petition given to him during the grievance day meeting to the Superintendent of Police on various dates. The reply furnished on 02.09.2009 is up to the point raised by the petitioner. Therefore, the Commission is satisfied with the information supplied though the petitioner is not satisfied with the information. If he wants to know the action taken by the Inspector of Police and the Deputy Superintendent of Police, he should re-phrase the questions and send fresh petition to the Inspector or to the D.S.P. or to the Public Information Officer in the S.P.'s office.

**3. With this observation, the case is treated as closed.**
