The Petitioner Thiru S. Ravi was present for today's (29.01.2010) enquiry which was held at the Collectorate, Ramanathapuram. The Public Authority was represented by the Public Information Officer Tmt. A. Jagadeeswari, Assistant Commissioner, Ponmalai Zone, Trichy City Corporation, Trichy.

Under the RTI Act 2005 sec.6(1) the petitioner sent a petition dated 17.08.09 addressed to the Public Information Officer seeking information on two items (1) On what basis the tax receipts for the above said property as stated supra has been granted to the said Devadass and copy of the same is required for all the documents submitted by Devadass when I am the owner of the property (2) Why when in my

name the tax has been changed in tax receipt No.31751 for the same property. The PIO sent reply to the petitioner on 19.09.09. Not satisfied with the reply given by the PIO, the petitioner made the second appeal under sec.19(3) straight away to the Commission on 20.9.09. On the basis of the petitioner's second appeal to the Commission both the petitioner and the PIO were summoned to appear before the Commission for hearing.

At the enquiry, the petitioner informed the Commission that the required information on two items has not been received from the concerned PIO till date. The PIO assured the Commission that the required information on two items will be furnished to the petitioner within two weeks. As per the assurance made by the PIO, the concerned PIO is directed to furnish the required information on two items to the petitioner within two weeks from the date of receipt of this order and send a compliance report to the Commission within three weeks from the date of receipt of this order.
