Order

1. The petitioner sent a petition under Section 6(1) of the Right to Information Act, 2005, on 28-06-2022 to the Public Information Officer, O/o the Director General of Police, Mylapore, Chennai, requesting information on 12 counts viz., "Please share with me steps taken in connected to the office of commissioner dated 20-06-2022, please share with me FIR copy, date of summons served to the respondent, share me the copy of the summons served to the respondent. If summons not served to the respondent as per section 64 & 65 of the code of the criminal procedure, 1973 share with me picture the serving officer affixed on of the duplicates of the summons to some conspicuous part of the house. If served as per section share the ;copy of the summons" and so on.

2. Thereafter, the Public Information Officer/Deputy Commissioner of Police, Adyar District, Chennai vide Letter C.No.272/DCA/RTI/ 2022

Dated 15-09-2022 furnished item-wise reply/information to the petitioner. Not having been satisfied with the information furnished, the petitioner sent a first appeal under Section 19 (1) of the RTI Act on 20-09-2022. Thereafter, the first Appellate Authority / Joint Commissioner of Police, South Zone, St. Thomas Mount, Chennai, sent a reply dt.19-10-2022 to the petitioner. Dissatisfied, the petitioner / appellant sent a Second Appeal under Section 19(3) of the RTI Act on 31-10-2022 to the Commission which was taken on file as SA No.21777/SCIC/2022.

3. On the basis of the above second appeal, the Commission sent a direction to the Public Information Officer on 27-03-2023 instructing to furnish the information to the petitioner. The Public Information Officer sent item-wise reply vide Letter C.No.272/DCA/RTI/2022 dt.27-09-2024 to the petitioner. On getting that reply, the petitioner sent an objection letter dt.17-03-2025 to the Commission.

4. This case was listed for today's enquiry and summons sent to both the parties. Petitioner was present for the enquiry. On behalf of the Public Authority, Thiru R.Pon Karthik Kumar, Deputy Commissioner of Police, Adyar, Chennai, was present.

5. Today, the Public Information Officer mentioned that on 15-09-2022, 19-10-2022 and 27-09-2024 item-wise reply / information sent. Petitioner stated that the reply dt.27-09-2024 was not received by him. Hence, a copy of the same was given to him by the Public Information Officer today. It can be seen that the petitioner in his first appeal mentioned that for items 5, 6, 8, 9 incorrect information was given to him. Today also the petitioner reiterated the same.

6. The Commission after careful consideration of the materials available on record and the oral submissions made by both the parties during today's enquiry, passes the following orders :-

The Public Information Officer shall send modified / correct information for items 5, 6 & 9 within 15 days by registered post acknowledgement due to the petitioner and send the AD card and reply copy to the Commission. Information sought in item 8 is vague and hence that cannot be ordered to be given. With these directions, the Second Appeal case is treated as closed.
